

1. This Memorandum of Agreement is entered into between THE INTERNATIONAL BANK FOR RECONSTRUCTION AND DEVELOPMENT, 1818 H STREET, N.W., WASHINGTON, D.C. 20433, U.S.A. (hereinafter called the Bank) and the DIRECCION DE RELACIONES INTERNACIONALES Y CONVENIOS, UNIVERSIDAD MAYOR DE SAN SIMON, AV. BALLIVIAN ESQ. REZA #591, COCHABAMBA, BOLIVIA (hereinafter called the Library). The Bank and the Library agree as follows:
  
2. The Bank designates the Library as a depository for a limited number of formally published print publications and CD-ROM products produced by the Bank. The deposit entitlement begins with the date of designation and is not retroactive.
  
3. The Library agrees to collaborate to the best of its ability with:
  - the Bank
  - the Bank's designated publications distributors in Bolivia, where such distributors have been designated, and
  - other designated World Bank depository and regional libraries within Bolivia, where such libraries have been designated
 to disseminate information on the work of the Bank, to its institutional users and wider professional constituency.
  
4. The Bank will provide to the Library a copy of print titles formally published by the World Bank in English and Spanish and a copy of formally published CD-ROM products as detailed in Annex A (hereinafter called Products). The Products will be shipped within a month of publication.
  
5. Titles in print published before the date of the depository designation or additional copies of depository items may be purchased from the Bank's designated publication distributors in Bolivia, or if none has been designated, from World Bank Publications, P.O. Box 960, Herndon, VA 20172-0960, USA. The current list of designated Bank distributors is attached as Annex B.
  
6. The Library agrees to keep the Bank collection under bibliographic control and in good order, to place the material received in the care of trained library staff, and to make it accessible to the public during normal business hours. Bibliographic control includes accessioning, cataloging, classifying, and shelving to ensure retrieval for library users.
  
7. The Library agrees to make deposited items available through interlibrary loans to users within its area who cannot easily visit the Library's facility.
  
8. The Bank will provide the Library with Publications Update, a quarterly catalog. Publications Update can be used by the Library as an accessions list, however not all Products listed in Publications Update will be provided to the Library (refer to Annex A). It provides bibliographic detail for newly released and forthcoming items.



9. The Library agrees to promote the availability of the Products to its user community, academic and professional community, and to other libraries throughout Bolivia. This will include issuing accession lists. The Library will also exhibit on arrival all new Bank publications and periodicals in those places where new acquisitions are displayed in the Library. Additionally, the Library agrees to organize, at least once a year, a special display devoted to World Bank publications.
10. The Library agrees to facilitate the purchase of the Products by making available to its user community the name and contact information for the designated Bank publications distributor (see Annex B), or – if none has been designated -- information on how to order directly from the Bank. Information on how to order directly from the Bank is attached as Annex C. Updated distributor lists and ordering information are available on [www.worldbank.org/publications](http://www.worldbank.org/publications).
11. Any change of address, or of the person responsible for administering activities under this agreement, should be promptly notified to the Bank. The Library should address such correspondence, including claims, to:

12. Before preparing a claim on an item not received by the Library, the Library must consider the following: (1) date of the depository designation, (2) extent of material covered by this Agreement, (3) when item became available, (4) if sufficient time has elapsed between publication date, probable shipping date, and transit time.
13. The following information must be included on the claim form: (1) name, address and account number of the library, and; (2) publication ISBN, author, title, and language desired if available in other than English.
14. The Bank holds copyright to all its published Products. Use of this materials is governed by "fair use", as defined in the Copyright Law of the United States of America (see <http://www.loc.gov/copyright/title17/92chap1.html#107>). Specifically, the fair use of a copyrighted work, including such use by reproduction in copies, for purposes such as criticism, comment, news reporting, teaching (including multiple copies for classroom use), scholarship, or research, is not an infringement of copyright.
15. This Agreement shall be valid in the first instance from the date of execution by the Bank until June 30, 2005. Approximately 90 days before the expiration of the Agreement the Bank shall send the Library a questionnaire which the Library shall complete and return within 30



days of receipt. The Bank will give consideration to renewing the Agreement on receipt of the completed questionnaire.

16. The Bank reserves the right to inquire as to the condition of the Products held by the Library by questionnaires and/or site visits by Bank staff.
17. The Bank may terminate this Agreement, in whole or in part, at any time:
  - a. for Convenience: the notice of such a termination shall state that termination is for the Bank's convenience, the extent of which performance under the Agreement is terminated, and the effective termination date.
  - b. for Cause: the Bank may terminate this Agreement for cause and withdraw all rights granted under this Agreement, if the Library fails to adhere to the provisions of this Agreement.
18. This memorandum constitutes the Agreement between the parties in its entirety. It may not be modified except by mutual written consent of the Bank and the Library.


