Memorandum of Understanding between the University of Nijmegen and the Universidad Mayor de San Simon

To continue to promote understanding and goodwill, to strengthen cultural ties, to broaden student and faculty experience and horizons, the University Medical Centre St Radboud/ University of Nijmegen, represented by its Dean Prof. dr. G.P. Vooijs and its Rector Prof. dr. C.W.P.M. Blom, and the Facultad de Medicina / Universidad Mayor de San Simon, represented by its Dean Dr. Enrique Santiago and its Rector Prof. dr. Augusto Argandona Yanez,

hereby enter into the following Agreement:

Article 1

The contracting Parties will strive to deepen the existing relations developed within the framework of the MHO/FORTSALUD programme in the sphere of scholarly cooperation and to develop new relations on the principle of mutual benefit and full reciprocity.

Article 2

The cooperation will involve the UMC St Radboud and possibly other Faculties of the University of Nijmegen; and the Faculty of Medicine and possibly other Faculties of the Universidad Mayor de San Simon. Detailed three-year-programs of cooperation will be drawn up by the Faculties involved. The first three-year program (2001-2003) is described in the MHO/Fortsalud II project, which has been approved for funding by the NUFFIC.

Article 3

Both Parties will consider an annual exchange of junior academic staff and/or students, as well as the annual exchange of senior academic staff. Applications of candidates, including outlines of the program to be carried out abroad, are subject to the approval of the receiving University. Both parties will promote and sponsor joint research projects in areas where their interests correspond.

Article 4

Both Parties will consider the possibility of organizing conferences, symposia, seminars and workshops.

Article 5

Both Parties agree to promote the development of relationships between the central libraries and to establish a regular exchange of publications by the two Universities.

Article 6

The Faculties involved of both Universities will review the details of the programs of cooperation and the progress of the cooperation annually.

Article 7

The Faculty of Medicine of the Universidad Mayor de Simon and the UMC/St Radboud agree to undertake joint activities to raise funds for the activities planned. Both Parties will try to use existing financial sources such as bilateral governmental agreements and exchange programs.

Article 8

Any changes and amendments in the text of the said Agreement shall be introduced only in writing and after the prior mutual consent of both Parties. These changes and amendments shall be treated as integral parts of the Agreement.


